- A. Negotiations: Agreement and Contract
 - 1. Custodial/Maintenance
 - i. Brad Wright leading
 - ii. Current contract is good through Jun 30, 2025
 - iii. Monetary changes increased salaries (3%), more clothing allowance, increased time in the work days.
 - iv. R. Grossheim vocalized that he would prefer for the board president to be part of all negotiations.
 - v. M. Dubois reports P. Bassage feels 3% raise is comfortable in the budget.
 - 2. Paraprofessionals
 - i. Wage increased by 2%
 - ii. Reimburse if they take the courses to become highly qualified
 - iii. Were the additional days added to the contract?
 - 1. Currently has 3 PD days in the contract
 - iv. "Highly qualified"
 - 1. Added to the new contract needs to be completed within 90 days
 - 2. Can we have staff that was previously grandfathered in be encouraged to take the exam?
 - a. Currently only have 3 paras that are not considered highly qualified
 - b. M. Dubois to look at getting that language in the contract
 - 3. Food Service
 - i. Kathy Albright leading
 - ii. Individual contracts versus group contracts very different due to district needs and times
 - iii. They were requesting in the contract:
 - 1. Jury duty language
 - 2. \$100 clothing allowance and 5 shirts
 - 3. Increase in retirement incentive
 - 4. Increase of 2.5% salary
 - 4. Teachers
 - i. Still working on:
 - 1. Language modifications
 - 2. Salary increases
 - 3. Caseload overage
 - ii. J. Galloway requesting copies of each current contract and the proposed changes
